I am curious if anyone was able to get an answer from the Board with regard to my tiling hours?

The last time I spoke with the interim CEO she had mentioned that partial hours could be considered.

If you can let me know, that would be great. If the board would like a statement from me, for the reasons I feel the hours should qualify, I can do that as well.

Finally, last year there was a task that we were told hours were to be awarded based on "packaged delivered" (it was 1/3 hour for each mail delivery) - however, I have since heard that the two other families that were doing this task were rewarded 2/3 per delivery (on account of their friends being allowed to claim the same packages delivered.) I'm sure you can see how I feel this wasn't fair (and I understand you had even suggested to one family that they could get double if they brought a friend, however I was not informed of this) - can I be awarded the same rate that the other two families received?
